2. You have read, understood and complied with the RULES OF ENTRY (CONTENT RULES AND ENTRY RULES) of the 1<sup>st</sup> ANNUAL FAITH AND VALUES SCREENWRITING COMPETITION. You are the author and sole owner of all rights to the submitted screenplay/teleplay, which was created without any request or suggestion by a third party that the material be written. You agree to indemnify the Competition, Ambassador Communications Inc., its associates, the Competition judges, sponsors, readers, and related parties against all damages, losses, expenses and liabilities if you do not satisfy the rules and regulations of the Competition.
3. You declare that all of the important features of your material are summarized in Exhibit A and you have disclosed no other features to AMBASSADOR COMMUNICATIONS INC. You warrant that the material is wholly original and was created solely by you, and that no one else to your knowledge has any right to it. You believe your material and its features to be unique and novel. However, you recognize that other persons may have submitted to AMBASSADOR COMMUNICATIONS INC. and to the 1<sup>ST</sup> ANNUAL FAITH AND VALUES SCREENWRITING COMPETITION or to others or made public, or may hereafter originate and submit, or make public, similar or identical material which AMBASSADOR COMMUNICATIONS INC. may have the right to use, and you understand that you will not be entitled to any compensation because of AMBASSADOR COMMUNICATIONS INC.'s use of such other similar or identical material.

4. Further to #3, you recognize that the companies listed on the website [www.ambassadorcommunications.biz/faithandvalues.html](http://www.ambassadorcommunications.biz/faithandvalues.html) or recognized as sponsors/judges/readers of the 1<sup>st</sup> ANNUAL FAITH AND VALUES COMPETITION may already have in their possession or may, in the future, have access to similar or identical materials, stories, ideas, themes, etc. such as those you are submitting to the 1<sup>st</sup> ANNUAL FAITH AND VALUES SCREENWRITING COMPETITION, and you understand that their use of these similar or identical stories, ideas, or themes will not entitle you to any compensation.
5. Any controversy arising as to whether AMBASSADOR COMMUNICATIONS INC. used your material, or relating to this agreement, will conclusively be determined by binding arbitration as provided by Manitoba law and the arbitrator will be a person experienced in the motion picture, television, and literary industries mutually selected by us. You agree that any action against AMBASSADOR COMMUNICATIONS INC. must be brought within six months after the date of AMBASSADOR COMMUNICATIONS INC.'s alleged first use of your material. In the event you bring any action, each party will bear his/her/its own costs relating to the arbitration, including attorney's fees.
6. You have retained a copy of your material submitted to AMBASSADOR COMMUNICATIONS INC. and release AMBASSADOR COMMUNICATIONS INC. from liability for loss or damage to such material.
7. This agreement constitutes our entire understanding. Any modification or waiver regarding this agreement must be in writing signed by both parties. The invalidity of any provision hereof shall not affect the remaining provisions. This agreement also applies to any other material you submit to AMBASSADOR COMMUNICATIONS INC. unless agreed in writing to the contrary.
